Authoritarian Regimes Data Set, available at <http://sites.psu.edu/dictators/>. The first tranche of data collected under the auspices of National Science Foundation/Department of Defense Minerva (NSF-BCS #0904478 grant for collection of data on authoritarian regimes (with Joseph Wright, Penn State University) was made public in January 2012. The data set so far includes beginning and end dates for authoritarian regimes between 1946 and 2010, autocratic type codes, mode of transition, regime type of succeeding regime, and violence during transition. I continue to work on about 30 time varying codes dealing with characteristics of autocratic rule. We expect to release additional data in early 2015.

This project proposes theories to account for several standard features of authoritarian politics. Subjects covered include the post-seizure narrowing of authoritarian coalitions, elite rivalries and succession, the creation of parties to support authoritarian rule, the uses of controlled elections, and the breakdown of authoritarian regimes.
